License Plate Readers to Support Crime Investigations – A New Campaign

As a 17-year resident of Morningside-Lenox Park on Berkshire Road, my husband and I have been concerned about the significant increase in burglaries in our neighborhood in 2024. To put the situation in perspective, within the interior of our neighborhood (not including Cheshire Bridge and Piedmont Roads) there have been 14 burglaries to date this year. and for the same period

last year, there were 6 – an increase of over 100%! What drove the situation really close to home, is when our neighbor two doors down became burglary victim number 9 in June. In case you haven't heard, there was yet another burglary on Sunday, October 13 th on N. Pelham.

There are numerous commonalities in the burglaries: the perpetrator targets homes where the homeowners are away, enters through the rear, and goes directly to the primary bedroom in search of designer handbags, watches, and jewelry. While there are things we can and should all do on our own to reduce our individual property risk, there is no one “silver bullet” for the larger community. Part of the solution is more nighttime security patrols. I was surprised to learn that based on our current MLPA membership, our community budget only allows for 23% security patrol coverage during evening hours. One of the other tools that the police advocate for are License Plate Reader cameras (LPRs) at the perimeter of our community to help in the investigation. A good friend of ours was the victim of a hit and run at the intersection of E. Rock Springs and Johnson Road a few years ago, and the LPRs were instrumental in finding the driver of the car.

Due to my recent retirement, I have volunteered to help the MLPA with a fundraiser to further advance our LPR deployment. Currently, MLPA has 11 LPR cameras deployed at the perimeter of the neighborhood. The full perimeter plan envisions 16 cameras, so I challenge us all to fund the 5 additional cameras by the end of 2024. Each camera costs \$8,500. To help us get off to a great start, our City Councilman Alex Wan has secured matching funds of \$7,500, so with donations of \$9,500, we can fund 2 cameras right away. After achieving that goal, we will need to raise \$25,500 for the remaining 3 cameras.

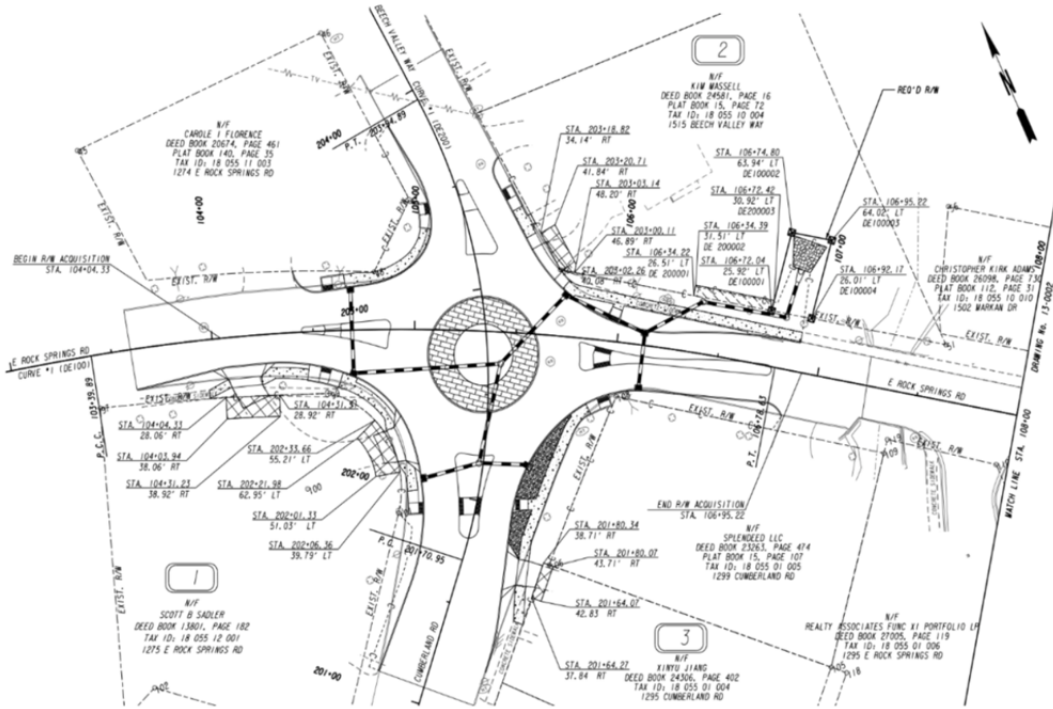
Roundabout at E Rock Springs/Cumberland/Beech Valley Coming 2025

Thanks to the generous support from Georgia State Senator Elena Parent, we anticipate that the long-awaited roundabout for the intersection of E Rock Springs, Cumberland Road, and Beech Valley should happen in 2025. The Dekalb County Board of Commissioners has approved construction contract. Unfortunately, it will likely be several more months before the contract is fully executed. Once that happens, the contractor will have one-year to complete the project.

E Rock Springs is a major thoroughfare in Morningside, that carries heavy east-west traffic during morning and evening rush hours. The intersection of Cumberland Road and E Rock Springs is particularly problematic because it is at the bottom of two steep hills, one from N Highland Avenue and the other from Briarcliff Road. There is not even a crosswalk at this busy and unsafe intersection. Pedestrians have no safe way to cross E Rock Springs to and from the Marta bus stop located there. Children who attend Morningside Elementary School and who live in Edmund Park do not have a safe way to walk to school.

There are numerous examples of unsafe incidents that resulted primarily from cars exceeding the posted speed limit. Over the recent past, there have numerous instances of neighbors'

mailboxes being taken out by a speeding car (for some, this is a repeat occurrence), wheelies in the intersection, cars hitting trees, etc. Earlier this year, the local US Post Office worker was thrown from her vehicle when a speeding car struck her vehicle. The installation of the roundabout will not happen soon enough.

Final Draft: Atlanta Beltline Subarea 6 Master Plan

The Atlanta BeltLine, Inc. (the BeltLine) has posted the final draft of the Subarea 6 [Master Plan](#) on its website. Their community engagement team plans to speak at both NPU-F and NPU-E in November. Subarea 6 includes Ansley Park, Midtown, Morningside-Lenox Park, Piedmont Heights, Sherwood Forest, and Virginia-Highland. The area also includes Piedmont Park, Atlanta Botanical Gardens, Ansley Mall, Midtown High School, and Ansley Golf Club.

The plan is available [HERE](#). We encourage you to take a look, as it provides guiding principles and a framework of recommendations for - but not limited to - parks and open space, traffic calming, mobility, future land use, and infill and redevelopment opportunities at commercial centers including Amsterdam Walk, Midtown Promenade, Ansley Mall and Monroe Kroger.

Final Draft Presentations are scheduled at [NPU-F](#) on November 20.

Atlanta Botanical Garden Expansion Plan

The Atlanta Botanical Garden (ABG) is planning its first expansion since 1976. The area will encapsulate parcels bounded by Piedmont Avenue, Westminster Drive, and the Beltline Eastside Trail. This project will expand the ABG to the Beltline with a new Visitor Center entrance and also includes an event space and maintenance building.

The ABG property is located in NPU-E. Of note, the plan proposes a new service road off Monroe Dr on Westminster Dr for maintenance building access. Along with the Midtown Neighbors' Association Land Use Committee, NPU-E has compiled all project applications and documents [here](#). They have also submitted [this letter](#) regarding concerns with the aforementioned proposed service road that will bisect public park space in the Piedmont Commons area of Piedmont Park. NPU-F has submitted a similar letter.

Thank you to City Councilperson Alex Wan for attending this month's MLPA Board Meeting and providing some additional insight (although the City has not yet received official design plans; the process kicks off at the NPU level):

- The Monroe Safe Street project proposes a new traffic light at the Monroe Dr/Westminster Dr intersection, making it an additional access point to Piedmont Park and the Beltline with enhanced pedestrian crossings.
- ABG is willing to pave Westminster Dr. It is currently a gravel road.
- There will be a gated entrance where the new access road enters ABG, which will only be for service/delivery vehicles.
- ABG will pay for the rebuilding of the current pedestrian bridge to handle service vehicles for their site and also Piedmont Park Conservancy's maintenance buildings.
- There will be a companion pedestrian path/entrance.
- It is believed that the intent is not to impact Dutch Valley Place or Dutch Valley Way. To ensure this and protect those residents and businesses, Alex will likely put parking and turn restrictions on these streets if this goes through.
- The Beltline will employ the same pedestrian safety crossings that it does with many other street-level crossings along the path.

SAP packages are reviewed by the Department of City Planning, ATL DOT, and Watershed in detail. This particular package will also be reviewed by the Atlanta Beltline Development Review Committee (DRC) and Department of Parks and Recreation due to its location. SAP packages are provided to impacted NPUs for Review & Comment Only.

If you would like to provide individual comments, you can send it to SAPcomments@atlantaga.gov before the SAP hearing on October 24th. Public comment can also be given at the hearing.

Trails ATL

The City of Atlanta and the PATH Foundation are working together to stitch the city together via multi-use trails and paths, called [Trails ATL](#). Planning efforts began in March 2024 and are currently in high gear focusing on public input and stakeholder guidance. In Rounds 1 and 2 of public involvement, the community provided input on preferred trail types and desired destinations. Round 3, the final community-driven research leg of this plan, launched October 10th.

The city's 12 council districts have been grouped in three clusters – West, North and South-East. **Morningside is in District 6 - the North Cluster - and a virtual public meeting will be held on October 16 at 6:30.** All meetings will be held on Zoom and can be joined [HERE](#).

Park Renovations in November

Starting in the third week of October, major renovations will begin with focus on the playscape surface and drainage, a new entrance at Cumberland Road and Cumberland Circle, a new picnic area on the top of the knoll, and cascading stone benches down the hill that will mitigate the erosion and water in the lower area, but also form "amphitheater" seating for concerts and hopefully even more events. In addition, we are getting a hose bibb along Sherwood Road

Hopefully even more efficient in addition, we are getting a hose bibb along Cherokee Road, making the watering of the lower area much easier and reduce the miles of hoses we have there now.

It will be disruptive. Much of the upper park area will be closed from time to time. We will need your cooperation to maintain a safe construction site. It will be a great time to visit Noble, Sunken Garden or Lenox-Wildwood.

We have had many meetings with the contractor, Lichy Commercial, and the plan looks great from the Friends perspective; it builds on the Vision Plan that we set out to implement in 2019. We will post the plans at the information kiosk. Expect the construction to take about 2 months to complete.

Aeration and Seeding on the Lower Park – October 12

The Friends group is committed to keeping the lower area green. The plan is to aerate, fertilize and seed in the fall, followed by fertilize in the spring. We will be at the park this Saturday and Sunday, October 12-13 to do our fall maintenance. As a result, we will need your help and cooperation staying off the lawn for a few weeks.

We are also making major improvements to the watering system. It will be less obtrusive, less water lines and will be fed by the new hose bibb going in on the lower level.

Stay tuned as we may need volunteers to help spread straw late Saturday and Sunday. We may call for a "pop-up" volunteer day if it is needed.

Rains Results in Record Setting Levels for South Fork Peachtree Creek (SFPC) Then Wind Downs Trees

Hurricane Helene wreaked havoc throughout the southeast and her effects were felt in Herbert

Taylor Park & Daniel Johnson Park. The South Fork Peachtree Creek (SFPC) rose to [record levels](#), overflowing its banks and pushing up Rock Creek at the confluence.

The waters had finally receded by Sunday and the trails were traversable. Along Rock Creek the black willow live stakes planted last winter survived and seemed to have done their intended job of slowing the velocity of the creek.

The water wasn't the only hazard to the park, however. Winds took down a few trees along both Rock Creek and SFPC. Atlanta Parks Department has been notified about the trees that we have noted, but if you see a tree blocking the trail, take a photo, note its location and send the picture and information to parkscustomerservice@atlantaga.gov.

Working in the park is a great way to learn about plants and wildlife, work up some sweat, and make new friends.

Morningside Nature Preserve

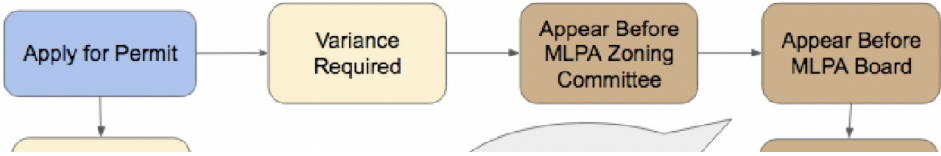

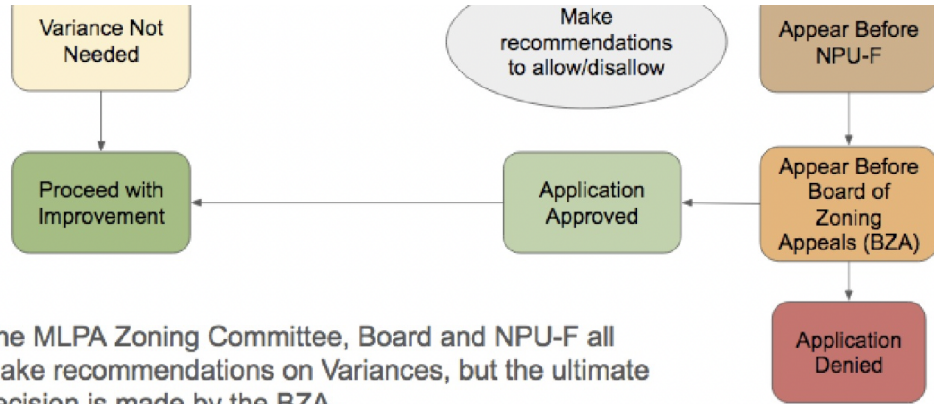

City of Atlanta's dedicated [Plan A](#) team invites you to discuss Plan A's Vision and Goals and Urban Design during Round 3 meetings this October. The overall vision for Atlanta will be discussed on October 21. On October 23, talks will highlight Atlanta's Urban Design.

Plan A Round 3 meetings run through February 2025 with greater efforts to engage more residents at nine public meetings corresponding to the nine chapters of the plan draft available at atlantaforall.com. Plan A is the update to the City's Comprehensive Development Plan (CDP) required every five years under state law. It sets forth the vision, goals, policies, and actions for future physical growth and development in Atlanta. Public input is critical to updating the plan.
